Dave Hanning - Swain, Skip Millor - Bristol Mountain, John Lawson - Hunt Hollow, Pete Peterson - Brantling, Cristina Hickok - Ski Valley, and the Patrol Representatives for Powder Mills, North Hampton and Genesee Valley Nordic.

#### **Region Awards:**

- 1. Region Outstanding Instructor (Lehman Award): awarded by Region goes to Division for consideration.
- 2. Region Outstanding Patroller (Stevens Award): awarded by Region goes to Division for consideration.
- 3, Region Distinguished Service Award Named the Doyle Award, honoring Dick Doyle, long time patroller, instructor and Mentor at Bristol Mountain. (New 1999)
- 4. Region Merit Star Given locally, automatic for rejected National Yellow Merit Stars.

#### **National Awards:**

- 1. **Gold Merit Star** National Outstanding Patroller including administrative, and instructor.
- 2. **Silver Merit** Runner-up to National Outstanding Patroller
- 3. **Purple Merit** Individually save or are primarily responsible for saving a life.
- 4. **Blue Merit** Outstanding or heroic use of ski patrol skills to save a life, but not to the level of the Purple. May be used to recognize those in supporting role of Purple.
- 5. **Green Merit** Similar to Blue but action took place in Ski area.
- 6. **Yellow Merit** Awarded for any outstanding act or service to NSPS. Must have an element of National relevance. May be used for supporting role for Green, Blue, and Purple.
- 7. **NSP Distinguished Service Award (DSA)** Given for outstanding achievement in place of a National or LCA. May be given to a non-Patroller.
- 8. **Patroller Cross Award** Awarded to a patroller who receives serious injuries while on duty. Patrollers killed in the line of duty are awarded the DSA.
- 9. **National Outstanding** Patroller, Instructor, Administrative, Professional, Auxiliary, or Student; Outstanding Patrol. Awards given in each category annually.
- 10. **Avalanche Award** Contributions to the avalanche program. Must have National significance.
- 11. National Appointments
  - a. Leadership Commendation (LCA) For deserving patrollers not eligible for National appointment.
  - b. National Appointment for eligible Seniors
- 12. Unit Citation -
- 13. National Certificate of Appreciation For "....."
- 14. **Service Recognition Awards** (10 years or more in increments of 5 year intervals.) Ordered by Patrol Director or Awards Committee.
- 15. **Honorary Awards** Non-Members given at the discretion of the Patrol Director, or Region Director. May be an NSP Award or Local or Region.
- 16. **Angel Pins** Primarily for spouses, but may be given to others for recognition of support to NSP or local patrolling efforts. Requested by Patrol Director to Division Director.

#### Henry Williams Legal

The Regional attorneys for Eastern Division met in Albany in September in a first-ever pow-wow put together by **Bob Scarlett**, the new Division attorney. The exchange of local policies and ideas concerning liability, labor laws and patrol operations was productive for the Division and very valuable for the regions, sections and individual patrols. Here are some of the items on which there was consensus:

- The police function to enforce safe skiing policies and remove transgressors from the hill is a necessary operational part of every ski area but an unpleasant task for the ski patrol on whom the responsibility normally falls. Some areas in the Division have taken safety as the starting point. They advertise the safe skiing policy to raise the level of consciousness. Thus, the enforcers become "safety implementers" and not policemen. Some areas have recruited an entirely separate force called "Rangers" to enforce the safely policy, a program which involves organization, uniforms and perhaps free skiers. Patrollers are likely easier and cheaper.
- As patrollers, we cannot successfully be sued for ordinary negligence in the performance of our rescue job. The Good Samaritan Law in New York protects us from that liability. Someone could join us as defendants in an action, but the case would have to be dismissed. A lawyer would have to be retained to make the dismissal motion, which costs money. We can be successfully sued by an injured party for wanton or gross negligence. This is defined as conduct rising to the level of intent to injure the patient or such want of care that the patient would inevitably be injured. The Good Samaritan Law does not protect against gross negligence or an intentional tort: where a patroller assaults someone, for example. Your area's insurance policy will cover the lawyer for the motion to dismiss in the ordinary negligence case or the lawyer and the damages resulting from gross negligence or even intentional conduct. But does your area have such an insurance policy? Your patrol director should determine annually whether the area has a policy of insurance covering patrollers. If there is a question about it, a copy of the facing page of the policy will suffice. Just in case, every patroller should go through his insurance agent to make sure he is covered by his homeowner's policy. Clip this article out and send it to your insurance agent and ask him to tell you that you're covered.
- Every patrol should collaborate with management on an accident investigation protocol. Kits which can be found and used right away should be prepared, containing a tape measure, graph paper, camera and witness forms. This topic will be discussed at the next Regional meeting.
- When an adverse attorney or party calls a
   patroller about an accident, the policy of the area
   should be that the patroller should not talk to the
   caller but report to the patrol director who will
   discuss the matter with area management and
   insurance counsel. Usually the lawyer selected by

- the insurance carrier will reply to the caller. As the saying goes, "It is not the responsibility of the patroller to make admissions. The patroller's function is to rescue."
- Sometimes patrollers are deeply involved in litigation arising out of an accident case as witnesses. They can be deposed by the attorney for the injured party and counseled before hand by the attorney for the area and then ultimately called at the time of trial to testify. This can be a very uncertain and nerve-racking time for a patroller. In case a patroller needs reassurance by someone who does not have a stake in the case but has knowledge about the litigation process, the Regional attorney should be consulted to talk about the case with the patroller and allay the uneasiness or insecurity.

Some areas in the region have new accident report forms. Look at them and ask questions before you have to use them. They are important documents, since they usually are the only "memory" that exists about what actually happened at an accident. You want to make sure for your own sake that the form is accurate and complete and is filled out at the time of the accident. Leave no blanks. "X" out or line through or put "N.A." for irrelevant spaces.

#### Alan Efron S&T

The season is once again off to a slow weather start -- but that's no reason not to be optimistic!! The Genesee Valley Region is very lucky to be hosting 2 Division events in addition to our own very full schedule of S&T activities. On Saturday and Sunday, January 29 and 30, we will be hosting the Skiing Enhancement Seminar. For only \$70, you get two days in a small group (10) with a PSIA level 4. If you want to work on your skiing skills this is the way to do it!! These SES sessions always get great evaluations. Call Mike Morgan at (716) 396-3073 or email him at tengoski@aol.com to sign up. The other Division program is the Women's Patroller Skills Seminar taking place Saturday and Sunday, March 13 and 14, for only \$50. **Deb Daniels** on both the Division S&T Staff and Steering Committee will be leading this session. The first seminar of this type was held last year and received excellent evaluations from the audience. This is an excellent opportunity for the women on our Patrols to get some focused instruction – instruction that is relevant to a women. The deadline for registration has been extended until February 1 – see the December issue of Trail Sweep for details and a registration form.

The Region is also offering a full slate of S&T activities this year as well. In January we will be offering an **S&T Phase 2 Program** led by our own **Joe Menichino**. Joe ran a Phase 2 back in 1998 and the ratings were mostly 5's!! If you are interested in being a local or regional

instructor, need a Senior elective, would like to beef up your instruction skills or want to do something fun consider this clinic. We will also be offering both a 1 day **Senior S&T "Challenge"** and the traditional **2-Day Senior Clinic**. The one day Senior Challenge is <u>"kinder and gentler"</u> than the old format. Even though it is still a test - second runs are allowed!! If you have been thinking about the Senior S&T Program, this is the year to go for it.

Of course, we will also be offering **Senior Continuing Education Clinics** at each of the Alpine areas this season. We guarantee a fun experience and everyone will get at least one tip they can use in either their skiing or sled handling. Each senior must attend one of these clinics every three years but these are clinics **NOT** tests. Attendance is all that is required to meet the requirement. These clinics also offer a great opportunity to ski at the other areas, so take advantage!!

At the Division clinic last week I saw some great boarding and telemarking – doing all of the activities that are covered in the clinics. I am hoping to see lots of boarders, telemarkers and patrollers of all sizes, shapes and colors at this year's events.
